# On final approval of the project of the Interreg V-A Latvia-Lithuania Cross Border Cooperation Programme 2014-2020

### Referring to:

- a. the Interreg V-A Latvia-Lithuania Cross Border Cooperation Programme's 2014-2020 (hereinafter Programme) Monitoring Committee's Decision taken at its meeting on 27–28 November 2017 to approve the Project No LLI-341, Social Inclusion of Elderly People (Aging in Comfort), (hereinafter Project) with certain conditions;
- b. Managing Authority's Decision No 5-41/10048 of 21.12.2017 on awarding of the funding of the Programme with certain conditions for the implementation of the Project;
- c. the fact that all the conditions and technical corrections have been fulfilled including additional correction made for Lead partner changing type of contracting Project coordinator (shift of funds from budget line (hereinafter BL) 1 to BL4 without increasing of planned budget).
